Construction and Demolition under solid waste management Rule-2016 ORDER

It has been brought to my notice that in the town, Construction and Demolition Waste being dumped on the site of roads, green areas and ditches. In order to ensure effective Construction and Demolition Waste Management in the Municipal Corporation, Yamunanagar-Jagadhri area, I, Girish Arora, HCS, Commissioner, Municipal Corporation, Yamunanagar-Jagadhri under section 243 of Haryana Municipal Corporation Act, 1994 and other relevant laws order to follow these instructions :-

- i) All Construction and Demolition Waste carrier owners who want to do this job are directed to get themselves registered with MC YNR-JAG. They shall display the registration number on the carrier painted with MCYNR-JAG logo in purple color.
- ii) Designated officer shall issue the certificate as per the enclosed Performa after obtaining the papers of registration etc. A model application file is attached herewith.
- iii) The principal originator of the C&D Waste shall provide Construction and Demolition Waste to registered carrier only otherwise he shall be challaned also as per NGT order with a fine of Rs. 5000/- (Rs. Five Thousand Only)
- iv) All these works shall be completed up to 10.11.2018 and no Construction and Demolition Waste carrier shall be allowed to operate without registration thereafter. Carrier shall be confiscated found violating above instructions and owner/operator shall be fined with Rs. 5000/-. This vehicle shall be released only after getting it registered with MCYnr-Jag as per NGT order at the first detection with 20% hike on subsequent detections, This C&D Waste carrier shall be released only after getting it registered with MCYnr-Jag.
- v) This arrangement shall be reviewed after 6 months and if, need be specific agencies may be hired for each zone to do this job.
- vi) This order shall be enforced by Enforcement wing under the direct supervision of concerned Joint Commissioners. The STP shall be the Nodal Officer from Commissioner, Municipal Corporation, Yamunanagar-Jagadhri. The concerned ME's shall check with the help of Sanitation Wing each and every carrier in their respective areas and handover the copy of this order and driver, their mobile no. and address and shall submit to Consultant Sanitation.
- vii) Construction and Demolition Waste carrier owner should pay Rs. 205/- per ton for the segregated C&D Waste and Rs. 565/- per ton for non segregated waste to MC YNR-JAG.
- viii) The Construction and Demolition Waste carrier owner should follow the C&D Waste Rule of 2016 which is punishable under sub-section (1) of Section 15 of the Environment (Protection) Act, 1986, i.e. in respect of each failure or contravention, be punishable with fine which may extend to one lakh rupees, or with both, and in the case of failure or

contravention continuing, with additional fine which may extend to five thousand rupee for every day during which such failure or contravention continues after the conviction for the first such failure or contravention.

- ix) The Construction and Demolition Waste carrier owner is not allow dump Construction and Demolition Waste anywhere else other the Construction and Demolition Waste processing plant.
3. This order shall come into force with immediate effect.
